To graduate from LEADERSHIP Jackson County, a participant is expected to attend a minimum of eight of the ten monthly sessions.

Orientation Retreat - Mandatory overnight stay in October from 5:00 p.m. until 3:00 pm the next day.
Monthly Sessions - One full weekday each month (2nd Thursday) October through March
Overnight trip to Montgomery – to be arranged; 2 working days
Graduation – to be arranged
