

## Governor Bob Riley Officially Welcomes HTPG to Scottsboro

Governor Bob Riley's last economic development announcement before leaving office was held on January 5 in Scottsboro, when he officially welcomed Heat Transfer Products Group, Inc. (HTPG) to the area. The ceremony, held at HTPG's facility in Scottsboro Industrial Park, attracted a crowd of approximately 100 people.

Formerly Carrier HTP and Witt Heat Transfer Products, HTPG was purchased by Monomoy Capital Partners, L.P. and they consolidated its Yuma, Arizona operations with the Scottsboro plant. HTPG is a manufacturer of commercial and industrial refrigeration equipment and the second largest provider of refrigeration products in the U.S., according to CEO John May.

"We appreciate all the hard work to help make this happen. We look forward to continued growth," said Plant Manager and Director of Operations, Paul Andrzejewski.

Governor Riley said, "John (May) wouldn't be here if it weren't for people in this room - people who take pride in their community."

## International Automotive Forum

Dus attended the 2010 International Automotive Forum (IZB) in Wolfsburg, Germany in October. A group of 12 economic developers including ADO, TVA, NAIDA, and several local communities participated. The IZB is a biannual tradeshow sponsored by Wolfsburg Chamber of Commerce. Wolfsburg is the world headquarters for Volkswagen, so this tradeshow is very important for suppliers seeking to do business with them. The State of Alabama and sponsoring communities had a booth at the show to provide a place for setting up appointments, and to provide literature highlighting the advantages of locating in our region. **TVA Hosts Open House**

The nuclear training center, which opened in September in the Jackson County Industrial Park at Hollywood, has already served almost 1,000 workers, and as many as 3,000 more are expected to go through the training during the first five months of this year.

**H&N Begins Production**

H&N Catalyst Manufacturing, LLC understands long-term commitment. This company established a manufacturing facility in the Scottsboro Industrial Park in 2002 as a joint venture of Hitachi Zosen and Nichias Corporation. Due to market and regulatory changes in the clean air act, they completed the factory and equipped it, but delayed production until 2010. H&N produces high-quality catalysts for removing air pollution particles in the smoke stack of coal power plants and chemical plants. We met with H&N's parent companies in Japan on numerous occasions and we are excited to see them beginning production. They have employed approximately 21 people and are hiring another 15 for a second shift. The market has improved and the company's long-term focus will pay off. We appreciate their commitment to Jackson County and wish them much success.
